# WORLD MINT PROMENADE APPLICATION

You may begin to erect your booth at 8 a.m. Monday, August 18, 2025. Dealer/Mint set up is from 8 a.m.-1 p.m. on Tuesday, August 19 (subject to change). You may begin to dismantle your booth no earlier than 4 p.m. Saturday, August 23, 2025. The bourse floor must be vacated by 7 p.m. Saturday. More information will be provided prior to the convention as to the hours and length of time for set-up.

**REFUND POLICY:** Should company/applicant cancel this contract for any reason, refunds shall be figured from the date designated as dealer move-in and according to the following schedule: More than 90 days prior to dealer move in, \$200 shall be retained by the ANA; less than 90 to 30 days prior, 50% of bourse fees shall be retained by the ANA; less than 30 days prior, 100% of bourse fees shall be retained by the ANA.

A security room will be available for all convention participants prior to set up. Armed guards will be furnished for the bourse and exhibit areas, but applicant is warned that the presence of security personnel or security systems does not constitute a guarantee against a loss. Applicants are expected to provide their own insurance against possible loss by fire, theft or other casualty.

All controversies and claims between applicant and ANA arising out of this application or the awarding or operation of a booth pursuant hereto shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by the arbitrators may be entered in any Colorado court having jurisdiction. The parties hereto agree that there shall be three arbitrators – one chosen by each of the parties hereto within 10 business days after demand is made, and a third to be chosen by the two named arbitrators. The costs and expenses of arbitration, including (but not limited to) the arbitrators' fees, shall be borne by the parties hereto equally or as the arbitrators shall determine. Any hearing held in conjunction with arbitration hereunder shall be in Colorado Springs, Colorado.
